**EMAIL POLL ITEM:** Board 2023 closure authorization and update.

**DISCUSSION**: This item is coming to the Douglas County Board of Trustees in keeping with Administrative Policies – Page 33, Item E – Closures - The Board annually approves the District holiday closures, and all District-wide closures unless due to extreme weather or emergency.

The Board directed Library leadership to recommend 9 holiday closures for 2023 eliminating 2 returning the Library to service on those days. The Board directed leadership to augment staff leave options with 2 floating holidays. The Board also directed an expedited decision to assist personal and professional planning – using an email poll to move forward instead of waiting for the next month's meeting. These were the holiday closures adopted in October 2022 – 11 in all.

\*Note that Federal services provide for closures on Mondays or Fridays where holidays fall on a nonstandard workday (Saturday or Sunday). Instead, DCL will allow staff to schedule and take an administrative day off in the pay period for any holiday on Saturday or Sunday.



The rational for dropping Columbus Day and Veterans Day is four-fold.

- 1) The Library hasn't traditionally closed on those days.
- 2) Retail, service-sector, and food-service business aren't traditionally closed on those days. Those holidays aren't as widely observed.
- 3) Schools are out on those days making the Library a valued-choice for activity on those days.
- 4) This allows the Library to assist with any Veteran's Day observances in communities without tasking staff to work on a holiday.

## FISCAL IMPACT:

The fiscal impact to remaining open for two additional days and adding two floating holidays is immaterial.
